Includes (i) 51 RSUs originally granted on January 5, 2022 that vest in equal monthly installments through January 1, 2026, (ii) 6,636 RSUs originally granted on July 1, 2022 that vest in equal monthly installments through July 1, 2026, (iii) 5,643 RSUs originally granted on January 1, 2023 that vest in equal monthly installments through January 1, 2027, (iv) 32,153 RSUs originally granted on July 1, 2023 that vest in equal monthly installments through July 1, 2027, (v) 53,256 RSUs originally granted on March 13, 2024 that vest in equal monthly installments through January 1, 2028, and (vi) 32,940 RSUs originally granted on May 21, 2025 that vest in equal monthly installments through January 1, 2029 and (vii) 50,000 RSUs originally granted on December 30, 2025 that vest in equal monthly installments through January 1, 2030.
